



We are approaching our first anniversary of when we moved to our own satellite service in Kaktovik, Anaktuvuk Pass, Atqasuk, and Point Lay. Although we have greatly improved the network reliability and almost tripled the capacity, we face the reality that demand will continue to outpace the bandwidth that can be delivered over satellite. The high cost of satellite capacity is the main prohibitive factor, but the high latency (delay) and environmental factors like the recent solar interference all contribute to the need for change.

For years we have been searching for the best solution to not only improve but to future-proof our connectivity to our final four markets. Traditional overland trenching of fiber optic cable is very

costly and potentially damaging to the tundra. The sheer quantity of water, lakes, and rivers across the North Slope drives the construction costs even further out of reach. Another key cost factor is also the lack of roads. Traditionally, fiber optic cables would be installed in easements along the edge of the road, or in the roadbed itself. Roads are what makes power and broadband expansion affordable across the rest of Alaska and in the lower 48. Road access greatly reduces not only the initial construction costs, but the ongoing operation and maintenance of the network. Imagine the cost difference to fuel and maintain a remote microwave site; with a truck, or with a helicopter.

Another major consideration in the evaluation is future-proofing. We need to build solutions that will deliver enough low latency capacity to meet the demands of 2030 and beyond. The lifespan of fiber optics is around 40 years or more, and the capacity expandability is constantly improving as the technology advances. Microwave solutions have some benefits, like lower construction cost per mile, but also has limitations, specifically to the amount of capacity that can be transferred. Microwave solutions also have a much higher cost of operation over time and can be interrupted by environmental factors.

As with most things in the Arctic, these types of projects are very expensive and the economics, even for a memberowned cooperative like ASTAC, is very hard to justify. We are fortunate that the federal government has recognized the importance of broadband access for all Americans, including those in the most remote parts of our country. The USDA has a series of programs that if awarded, can make the business case more sustainable. Specifically, the Community Connect and ReConnect programs have directed funding to expand broadband to even the most remote parts of America, including remote Alaska.

ASTAC has been successful in our efforts to garner some of these funds to expand our network. Over the past few years, we have applied for both programs. Earlier this spring we were awarded a \$3M Community Connect Grant to build an overland ground-layed fiber-optic extension from Utqiaqvik to Atgasuk as well as new fiber to the home network there. This fiber will not be trenched like traditional builds, but rather nested into the vegetation at a fraction of the cost. Additionally, just last month we were informed that our application to the USDA's ReConnect (round two) was selected for a \$5.3M grant award. These funds, along with a ~\$2M ASTAC investment, will allow us to fulfill our vision to extend our microwave network from the eastern oilfields to Kaktovik and complete the Fiber to The Home (FTTH) network there as well. We are making progress and building traction, but both are multi-year projects and require a tremendous amount of engineering, planning, and resources to complete. Beginning this winter we will start construction of the Atgasuk fiber project with a goal to have the link in service by spring of 2022 and next summer we will kick off the Kaktovik build. Look for updates on our progress in future Messenger issues.
